## INVITATION TO BID PROVISION OF SECURITY SERVICE 2017

- 1. The MARIVELES MENTAL HOSPITAL, through the Approved National Expenditure Program of 2017 intends to apply the sum of **One Million Eighty Thousand Pesos (P1,080,000.00)** being the Approved Budget for the Contract (ABC) for **Provision of Security Services 2017-01.** Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The MARIVELES MENTAL HOSPITAL now invites bids for Provision of Nine (9) guards on 24-hour service to provide security to hospital personnel and facilities and Installation of CCTV in 12 strategic areas of MMH Compound. Delivery of the Security Services is required on March December 2017. Bidders should have completed, within 2 years from the date of submission and receipt of bids, a contract similar to the Project with an amount of at least 50% of the proposed project for bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

- 4. Interested bidders may obtain further information from MMH BAC Secretariat and inspect the Bidding Documents at the address given below during M-F; 8am-12nn,1pm-5pm.
