## **INVITATION TO BID**

### **PROCUREMENT OF FOOD STUFFS 2017**

1. The MARIVELES MENTAL HOSPITAL, through the Approved National Expenditure Program of 2017 intends to apply the sum of ***Fourteen Million Five Hundred Ninety Nine Thousand Two Hundred Eighty Six & 50/100 Pesos (P14,599,286.50)*** being the Approved Budget for the Contract (ABC) for the ***Procurement of Food Stuffs 2017-03***. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The MARIVELES MENTAL HOSPITAL now invites bids for the procurement of the above-caption package. Delivery of the Goods is required within 10 working days. Bidders should have completed, within **2 years** from the date of submission and receipt of bids, a contract similar to the Project with an amount of at least 50% of the proposed project for bidding. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

4. Interested bidders may obtain further information from MMH – BAC Secretariat and inspect the Bidding Documents at the address given below during M-F; 8am-12nn, 1pm-5pm.
5. A complete set of Bidding Documents may be purchased by interested Bidders on ***January 09, 2017 to February 05, 2017*** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of ***Twenty Five Thousand Pesos (P25,000.00)***
