Requirements if Awarded the contract			
1. The supplier shall provide orientation/training on the use and maintenance of the vehicle to be agreed upon by Procuring Entity and the winning bidder.			
2. The supplier shall submit/provide the following to the end-user:			
a. Operator's manual in english language for the vehicle.			
b. Warranty certificate for not less than three (3) years on parts and not less than five (5) on services for the vehicle. The manufacturer/dealer shall either repair or replace any item or part in the vehicle that is found to be defective in material or in workmanship under normal use. The warranty period shall commence from the date of acceptance by the end-user after testing and commissioning.			

The warranty certificates shall include the following:

- i. That the warranty for the vehicle shall not be affected in case a change of dealer occurs.
- ii. That the vehicle is unable to return to the service center during the warranty period. The manufacture/ dealer shall provide mechanics and/or technician that can perform on site service and maintenance provided that the end-user will shoulder the travel expenses.

3. Warranty certificate for two (2) years on parts and services for instruments and vehicles accessories. The supplier shall either repair or replace any item or part in the said equipment that is found to be defective in material or in workmanship under normal use. The warranty period shall commence from the date of acceptance by the end - user after testing and commissioning. The warranty certificate shall include the following:

- i. The bidder shall conduct the necessary corrective maintenance within fifteen (15) calendar days upon notification of equipment breakdown the end-user.
- ii. The bidder shall have the primary responsibility and accountability to ensure that in case of defects, the vehicles, equipment, instruments and/or peripherals are appropriately repaired or replaced and shall be in good working condition thereafter.

4. At least three (3) years validity of vehicle Land Transportation Office (LTO) registration with red plate

5. Third Party Liability (TPL) vehicle insurance for one (1) year and comprehensive GSIS vehicle insurance for the one (1) year.

Delivery:

- 1. The delivery of the vehicle must be completed within 90 calendar days upon receipts of the notice to proceed.
- 2. Upon delivery, the vehicles shall undergo preliminary inspection by the Inspection Team of the Procurement Entity to ascertain the physical condition and acceptability of the unit.
