CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of July 2023, between MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL – P. Monroe St., Poblacion, Mariveles Bataan (hereinafter called "the Entity") C & J MACHINE TRADING – Blk 11 Lot 10 Sapphire St. Merry Homes, Calocan City (hereinafter called "the Supplier").


