**CONTRACT AGREEMENT**

THIS AGREEMENT made this 31 JUL 2023 day of July 2023, between **MARIVELES MENTAL WELLNESS AND GENERAL HOSPITAL – P. Monroe St., Poblacion, Mariveles Bataan** (hereinafter called "the Entity") **GLOBO ASIATICO ENTERPRISES, INC. – JDK Building 127 Maginhawa Street, Teacher's Village-East, Diliman Quezon, Manila** (hereinafter called "the Supplier").

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services therein in conformity in all respects with the provisions of the Contract as follows:

The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.


